WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of ELEVEN THOUSAND FIVE HUNDRED AND NO/100----- DOLLARS

(\$ 11,500.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is ten years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

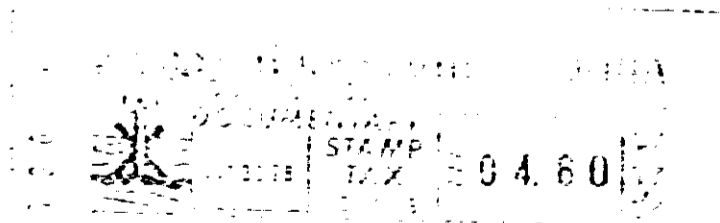

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All ~~that~~ certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the easterly side of Staunton Bridge Road, being shown as Lot No. 3 and Lot No. 4 on a plat of Elizabeth Heights Subdivision, a plat of which is dated May 1, 1956 and recorded in Plat Book KK at page 11 in the RMC Office for Greenville County and having according to said plat the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the easterly side of Staunton Bridge Road at the joint front corner of Lot 2 and Lot 3 and running thence with Lot 2 S 73-50 E 147.8 feet to an iron pin at the joint rear corner of Lot 2 and Lot 3; thence with Lot 62 and Lot 61 S 16-10 W 135.3 feet to an iron pin on the northerly side of Satterfield Drive; thence with said drive N 73-50 W 132.4 feet to an iron pin; thence N 35-55 W 33.5 feet to an iron pin on Staunton Bridge Road; thence with said road N 22-0 E 43 feet to an iron pin; thence still with Staunton Bridge Road N 17-57 E 67.3 feet to the point of beginning."

This is the same property conveyed to the mortgagor by deed of Robert W. Davis, Jr. et al, recorded on May 25, 1973 in Deed Book 975 at page 402 and by deed of Marion W. Fore, et al, recorded on February 4, 1977 in Deed Book 1050 at page 571 in the RMC Office for Greenville County.
