Twenty-three Thousand and 00/100----- DOLLARS

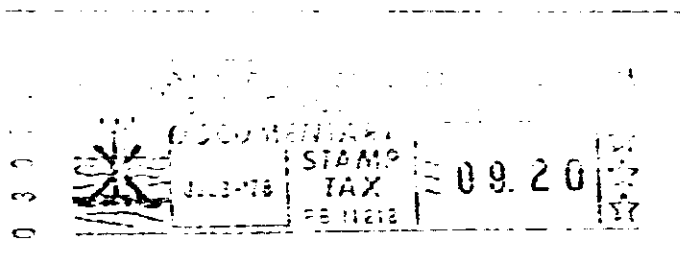
