(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Sixty-one Thousand Two Hundred and No/100----- DOLLARS

(\$ 61,200.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 1 1/2 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the Southeasterly side of Briar Creek Road, near the City of Greenville, S. C., and being known and designated as Lot No. 100 on plat entitled "Map No. 5, Sugar Creek", as recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 6-H at page 2, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Southeasterly side of Briar Creek Road, said pin being the joint front corner of Lots Nos. 100 and 101 and running thence with the common line of said lots S. 57-26 E. 152.24 feet to an iron pin, the joint rear corner of Lots Nos. 100 and 101; thence S. 40-38 W. 106.05 feet to an iron pin, the joint rear corner of Lots Nos. 99 and 100; thence with common line of said lots N. 57-26 W. 137.35 feet to an iron pin on the Southeasterly side of Briar Creek Road; thence with the Southeasterly side of Briar Creek Road N. 32-34 E. 105 feet to an iron pin, the point of beginning.
