TO ALL WHOM THESE PRESENTS MAY CONCERN: United Builders, Inc.

All that piece, parcel or lot of land situate, lying and being on the southeastern side of Honeybee Lane, near the City of Greenville, in the County of Greenville, State of South Carolina, and known and designated as Lot 18 of a subdivision known as Pebble Creek, plat of which is recorded in the RMC Office for Greenville County in Plat Book 5D, at page 5, and according to said plat, has the following metes and bounds to wit:
