TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, CECIL L. PEE AND LAURIE H. PEE

(hereinafter referred to as Mortgagor) is well and truly indebted unto JENK'S, INC.

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of FIVE THOUSAND FOUR HUNDRED TWENTY-ONE AND

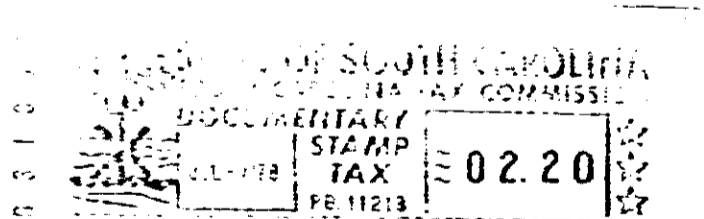
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and shown on a plat of property of Cecil L. Pee prepared by C. O. Riddle, R.L.S. in June, 1978, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book CR Page 50, which plat shows 5.02 acres and the following metes and bounds, to-wit:

BEGINNING at an iron pin near the intersection of Bordeaux Drive and Marseille Drive and running thence S. 87-54 E. 23.9 feet to an iron pin; thence S. 26-24 E. 273 feet to an iron pin; thence turning and running S. 30-38 W. 794.85 feet to an iron pin; thence N. 59-22 W. 250 feet to an iron pin on the southeastern side of Bordeaux Drive; thence along the edge of Bordeaux Drive N. 30-38 E. 932 feet to the point of beginning.
