(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto The Bank of Travelers Rest

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of seven thousand five

hundred and no/100ths-----DOLLARS (\$7,500.00 ),

with interest thereon from date at the rate of nine per centum per annum, said principal and interest to be repaid: in monthly installments of \$120.67 each commencing May 15 1978 with a like payment on the same date of each month thereafter until paid in full. All payments to be applied first to interest and then to principal. At the option of the mortgagee, the indebtedness secured hereby shall become due and payable if the mortgagor shall convey the mortgaged premises or if the title thereto shall become vested in any other person or party for any other reason whatsoever.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the South-western side of an unnamed County Road and being shown on plat of Property of Norwood C. and Ruth S. Bryant prepared by R. K. Campbell dated October 5, 1961, recorded in the RMC Office for Greenville County in Plat Book ZZ at Page 43 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwest side of said County Road, which iron pin is 638 feet from the center line of Dacusville Road, and running thence, S 43-55 W 242.7 feet to an iron pin; thence, N 65-0 W 111 feet to an iron pin; thence N 43-55 E 278.7 feet to an iron pin; thence along said County Road, S 46-05 E 105 feet to the point of beginning and containing 0.63 acres, more or less, and being the same property conveyed to the Grantor by deed recorded in Deed Book 827 at Page 138 in the RMC Office for Greenville County.
