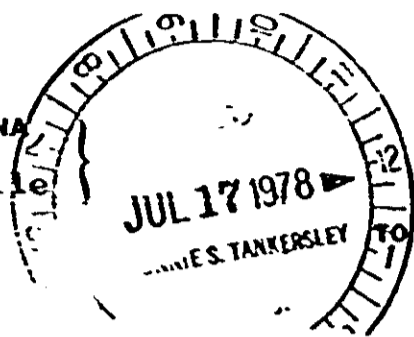

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, I, the said George A. Gillis

(hereinafter referred to as Mortgagor) is well and truly indebted unto Pickensville Finance Company

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Four thousand one hundred twenty-eight and no/100-- Dollars (\$ 4,128.00-- ) due and payable in 48 successive monthly payments of Eighty-six and no/100 (\$86.00) Dollars on August 5, 1978 and Eighty-six and no/100 (\$86.00) Dollars on the 5th. of each and every month thereafter until the entire amount is paid in full.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as Lot No. 63, Section A, on plat of prepertry known as "A Subdivision for Woodside Mills, Greenville, South Carolina," prepared by Pickell & Pickell, Engineers, dated January 14, 1950 and recorded in the RMC Office for Greenville County, S. C. in plat book W at pages 111-117.

The above described premises were conveyed to George A. Gillis and Helen L. Gillis for the consideration of \$8,250.00 on April 30, 1969 by deed recorded May 1, 1969 in deed book 867 at page 149 in the RMC Office for Greenville County, S. C. Subsequently, Helen L. Gillis conveyed all her interest to said property to George A. Gillis by a deed recorded August 31, 1972 in deed volume 953 at page 598 in the RMC Office for Greenville County, S. C. George A. Gillis is now the sole owner of record of said property.
