All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot No. 132, Paramount Park on plat recorded in the RMC Office for Greenville County, South Carolina, in Plat Book W at Page 57 and having, according to said plat, the following metes and bounds, courses and distances, to-wit:

BEGINNING at a point on the southern side of Crosby Circle joint front corner of Lots Nos. 132 and 133, and running with said Circle, N. 64-00 E. 70 feet to a point, joint front corner of Lots Nos. 132 and 131; thence with the common line of said lots, S. 26-00 E. 150 feet to a point; thence S. 64-00 W. 70 feet to a point; thence N. 26-00 W. 150 feet along the common line of Lots Nos. 133 and 132 to a point on the southern side of Crosby Circle, the point of beginning.
