MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

We, JAMES M. DARBY and JEAN M. DARBY

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

FORTY ONE THOUSAND, FIVE HUNDRED AND No/100----- (\$ 41,500.00)

Dollars, as evidenced by Mortgagor's promissory note of even date herewith which note does not contain a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain conditions), said note to be repaid with interest as the rate or rates therein specified in installments of THREE HUNDRED AND NINETEEN and 11/100----- (\$ 319.11) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 30 years after date; and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

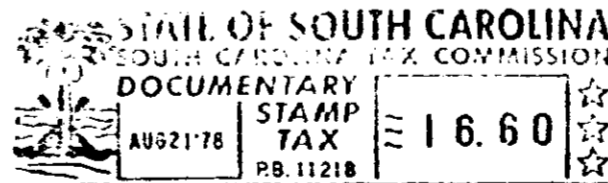

All that certain piece, parcel, or lot of land, with all improvements thereon or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot No. 23 on plat of PEBBLE CREEK, Phase I, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book 5-D at Page 5, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at the northeastern most corner of Lot 22 on Honey Bee Lane and running with Honey Bee Lane N 58-52 E 120' to a point; thence turning and running S 73-54 E 33.84' to a point; thence running along Roberts Road S 22-00 E 82.38' to the joint front corners of Lots 23 and 24; thence turning and running S 38-37 W 226.39' along the common line of Lots 23 and 24 to the joint rear corner of Lots 23 and 24; thence turning and running N 7-03 W 202.15' to the beginning point.
