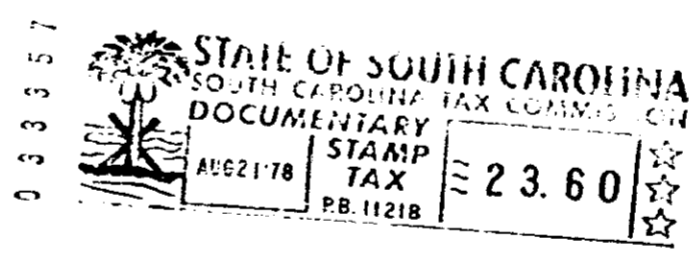
THIS MORTGAGE is made this 21st day of August 1978, between the Mortgagor, BOBBY LEE HOOPER and MYRNA K. HOOPER (herein "Borrower"), and the Mortgagee, POINSETT FEDERAL SAVINGS AND LOAN ASSOCIATION of Travelers Rest, a corporation organized and existing under the laws of U.S., whose address is 203 State Park Road, Travelers Rest, S. C. 29690 (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of FIFTY NINE THOUSAND and no/100 Dollars, which indebtedness is evidenced by Borrower's note dated August 21, 1978 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on January 1, 2008

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina: in Chick Springs Township, containing 5 acres, more or less, as shown on plat of Clifton H. & Maude D. Simmons, by C.O. Riddle, dated January 1968, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the eastern side of Clifton Acres Road, at the corner of a 4 acre tract, and running thence S 73-43 E 417.5 feet to an iron pin; thence S 16-17 W 500 feet to an iron pin; thence N 45-39 W 260.6 feet to an iron pin; thence N 42-57 W 285.5 feet to an iron pin; thence S 86-50 W 172.7 feet to an iron pin; thence N 16-73 E 288.6 feet to an iron pin; thence S 73-43 E, along a 5.03 acre tract and Clifton Acres Road 220.3 feet to the point of beginning.

This is the same property conveyed to the grantors by Charles Robert Simmons, et al. in deed book 1066, page 333, recorded October 6, 1977.

To HAVE AND TO HOLD unto Lender and Lender's successors and assigns, forever, together with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances, rents, royalties, mineral, oil and gas rights and profits, water, water rights, and water stock, and all fixtures now or hereafter attached to the property, all of which, including replacements and additions thereto, shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate if this Mortgage is on a leasehold) are herein referred to as the "Property".

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
