NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 48 as shown on plat of CANTERBURY, SECTION II, recorded in plat book 6 H page 22 of the RMC Office for Greenville County, S. C., and having according to said plat the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the south side of Sheffield Drive, the joint front corner of Lots 47 & 48, and running thence with the joint line of said lots S. 23-21 W. 139.99 feet to an iron pin in line of Lot 54; thence with the joint line of Lots 48 and 54, S. 66-44-40 E. 61.21 feet to an iron pin corner of Lot 53; thence with joint line of lot 48 and lot 53, S. 75-42 E. 67.36 feet to an iron pin joint rear corner of Lots 48 and 50; thence with the joint line of said lots N. 12-13-54 E. 139.30 feet to an iron pin on the south side of Sheffield Drive; thence with the south side of said street N. 72-12-33 W. 76.03 feet to an iron pin; thence continuing N. 72-12-33 W. 25 feet to the point of beginning.
