
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and lying and being on the Northwesterly side of Briar Creek Road, near the City of Greenville, South Carolina, being known and designated as Lot. No. 83 on plat entitled "Map 5, Sugar Creek" as recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 6-H, page 2 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwesterly side of Briar Creek Road, said pin being the joint front corner of Lots 82 and 83; and running thence with the common line of said lots N 66-44-35 W 146.62 feet to an iron pin the joint rear corner of Lots 82 and 83; thence S 22-41-05 W 147.87 feet to an iron pin the joint rear corner of Lots 83 and 84; thence with the common line of said lots S 69-46 E 151.55 feet to an iron pin on the Northwesterly side of Briar Creek Road; thence with the Northwesterly side of Briar Creek Road; thence with the Northwesterly side of Briar Creek Road N 20-14 E 94.5 feet to an iron pin; thence continuing with said road N 21-44-43 E 45.52 feet to an iron pin, the point of beginning.

This conveyance is subject to all restrictions, setback lines, roadways, easements, including a 25 foot sewer easement across rear lot line, and right of ways, if any, affecting the above described property.
