(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Fourteen Thousand and 00/100-----

-----Dollars (\$ 14,000.00) due and payable
in Six Hundred Twenty-Four (624) weekly installments of Thirty-Six and
71/100 (\$36.71) Dollars each until paid in full, the first installment
being due August 31, 1978

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

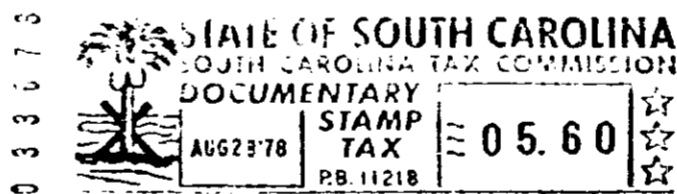
"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

Greenville, in Dunklin Township, containing one (1) acre, more or less, and being more particularly shown and designated on a plat prepared by Carolina Surveying Co. as follows, to-wit:

BEGINNING at a point 1060 feet, more or less, in a southeasterly direction from the Old Stone point, common corner of property of John L. Armstrong, now or formerly, and mortgagors herein; and running thence N. 19-30 E. 290.4 feet to a new point; thence turning and running thence S. 70-30 E. 150 feet to a new point; thence turning and running S. 19-30 W. 290.4 feet to a new point; thence turning and running along Sweetwater Road N. 70-30 W. 150 feet to the point of beginning.
