MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

We, T. GOUDY MILLER and FREDNA T. MILLER

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

FIFTY FOUR THOUSAND, FIVE HUNDRED and No/100-----

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of FOUR HUNDRED. AND

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any fadure to comply with and abide by any By-Laws or the Charter of the Mortgage, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (53.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, between Augusta Road and Reedy River, south of the Greenville Country Club golf course, on the north side of Brookside Way in subdivision known as MARSHALL FOREST, and being known and designated as Lots Nos. 152, 153, 154, 155, 156 and 157, as shown on plat of said subdivision, prepared by Dalton & Neves, Engineers, October, 1928, which plat is recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book H at Pages 133 and 134, and having, when described together, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Brookside Way, the joint front corner of Lots Nos. 151 and 152, and running thence along the joint line of said lots, N. 39-22 W. 178.5 feet to an iron pin in line of Lot No. 147; thence along line of Lot No. 147, S. 50-38 W. 160 feet to iron pin in line of Lot No. 158; thence along joint line of Lots Nos. 158 and 157, S. 39-22 E. 222.2 feet to iron pin on north side of Brookside Way; thence along north side of Brookside Way, N. 32-29 E. 136.5 feet to iron pin; thence continuing along said Brookside Way, N. 47-39 E. 30 feet to npoint of beginning.

This is the same property conveyed to the mortgagors herein by deed of Doris Kohler Shockley, dated June 25, 1976, and recorded that same date in Greenville County Deed Book 1038 at Page 670.
