TO ALL WHOM THESE PRESENTS MAY CONCERN:

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Seven Thousand Five Hundred and No/100-----

Dollars (\$ 7,500.00 ) due and payable

with interest thereon from maturity at the rate of nine per centum per annum, to be paid: at maturity.

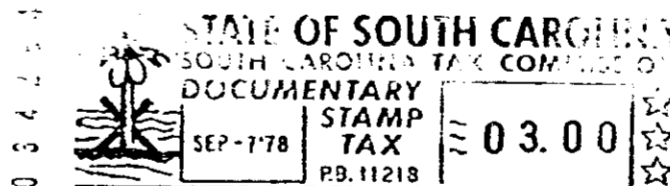
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeastern side of Third Avenue and being known and designated as Lot No. 111 on a plat of F. W. Poe Mfg. Co. recorded in the RMC Office for Greenville County in Plat Book Y at Pages 26 and 27 and being shown on a more recent plat entitled "Property of Robert H. Wynne, Jr.", prepared by Carolina Surveying Company, dated September 6, 1978, recorded in the RMC Office for Greenville County in Plat Book 6-1 at Page 20, and having, according to the more recent plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Third Avenue, joint front corner of Lots 110 and 111 and running thence N.48-36 E. 99 feet to an iron pin; running thence S.41-20 E. 75 feet to an iron pin; running thence S.48-36 W. 99 feet to an iron pin on the northeastern side of Third Avenue; running thence with said Avenue, N.41-20 W. 75 feet to the point of beginning.

THIS is the same property as that conveyed to the Mortgagor herein by deed from Ella H. Spencer recorded in the RMC Office for Greenville County on September 7, 1978.
