THIS MORTGAGE is made this 7th day of September 1978, between the Mortgagor, LOLLIE G. GIBSON and D. B. FLEMING (herein "Borrower"), and the Mortgagee, Family Federal Savings & Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 713 Wade Hampton Blvd. Greer, South Carolina (herein "Lender").

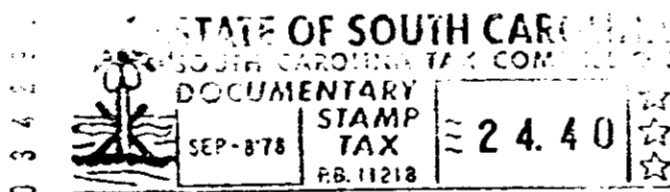
WHEREAS, Borrower is indebted to Lender in the principal sum of SIXTY ONE THOUSAND AND NO/100ths Dollars, which indebtedness is evidenced by Borrower's note dated September 7, 1978 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on September 1, 1993

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of GREENVILLE, State of South Carolina: on the easterly side of Waddell Road, being more particularly described on a plat entitled, "Property of Lollie G. Gibson", prepared by Clark Olin Riddle, Surveyor, dated February 9, 1978 and recorded in Plat Book 6N at page 18.

THIS is the identical property conveyed to the Mortgagors by deed of SCHOOL DISTRICT OF GREENVILLE COUNTY, recorded in Deed Book 1012 at page 560 on January 2, 1975 in the RMC Office for Greenville County.

ALSO all that adjoining lot of land in said State and County located at the Northeasterly corner of Waddell Road and an unnamed street and being more particularly described on a plat entitled, "Property of Lollie G. Gibson, prepared by C. O. Riddle, Surveyor, dated February 9, 1978 and recorded in Plat Book 6-T at page 26.

To HAVE AND TO HOLD unto Lender and Lender's successors and assigns, forever, together with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances, rents, royalties, mineral, oil and gas rights and profits, water, water rights, and water stock, and all fixtures now or hereafter attached to the property, all of which, including replacements and additions thereto, shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate if this Mortgage is on a leasehold) are herein referred to as the "Property".

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
