

MORTGAGE

All that certain piece, parcel or lot of land, situate, lying and being in the State and County aforesaid, in the City of Greer, on the West side of Poplar Drive (formerly known as New Pelham Road), and having the following courses and distances, to-wit: Beginning at an old Iron Pin on the West side of Poplar Drive and which Iron Pin is S. 1-08 W. 193 feet from the Southwest intersection of Poplar Drive and Cannon Avenue, and running thence from said old Iron Pin and with the West side of Poplar Drive S. 1-08 W. 60.9 feet to a Stake on West side of Poplar Drive; thence N. 88-48 E. 155.2 feet to an old Iron Pin; thence N. 2-10 W. 59.7 feet to an old Iron Pin; thence S. 89-13 W. 151.7 feet to the beginning point. This is the same property conveyed to David M. Jones and the Mortgagor herein by Jesse N. Evans and Vermel L. Evans by deed recorded in the R.M.C. Office for said County on July 21, 1970, in Deed Book 894 at page 386. David M. Jones conveyed his one-half undivided interest in and to the above described property to the Mortgagor herein by deed to be recorded forthwith in said Office.
