do hereby agree to pay all taxes and other public assessments against this property on or before the first day of January of each calendar year, and to exhibit the tax receipts at the office of the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., immediately upon such payment, until all amounts due under this mortgage have been paid in full; and should fail to pay said taxes and we other governmental assessments, the Mortgagee may, at its option, pay same and charge same amounts to the mortgage debt, and collect the same under this mortgage, with interest thereon.
