

State of South Carolina: being shown and designated as Lot 29 on a Plat of Section H of CROFTSTONE ACRES, recorded in the RMC Office for Greenville County in Plat Book Y, at Page 91. Said Lot fronts 70.0 feet on the northern side of Broughton Drive; runs back to a depth of 200.4 feet on its eastern boundary; runs back to a depth of 200.9 feet on its western boundary, and is 70.0 feet across the rear.

This is the same property conveyed to the Mortgagors herein by deed of Harold L. Davis and Annie Laurie L. Davis, dated September 15, 1978, to be recorded simultaneously herewith.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:

1. That he will promptly pay the principal of and interest on the indebtedness evidenced by the said note, at the times and in the manner therein provided. Privilege is reserved to pay the debt in whole, or in an amount equal to one or more monthly payments on the principal that are next due on the note, on the first day of any month prior to maturity; provided, however, that written notice of an intention to exercise such privilege is given at least thirty (30) days prior to prepayment.
