"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All piece, parcle and tract of land lying and being in Gantt Township, Greenville County, South Crolina, located about five or sixmiles from the city of Greenville, and being a portion of the Jefferson Ware homeplace. It contains 1.34 acres according to survey and plat made by J. Mac Richarson, Reg. Land Surveyor, under date of April 12, 1956.
