WHEREAS, the Mortgagor may bereafter become indebted to the Mortgagoe for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW. KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (53.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:


All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of

ALL that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 67 of a subdivision known as Gower Estates Section F according to a plat thereof prepared by R.K. Campbell, November 1965 and recorded in the R.M.C. Office for Greenville County in Plat Book JJJ at Page 99 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Aldridge Drive, joint front corner of Lots 66 and 67 and running thence with the joint line of said lots, N. 20-48 W. 207.3 feet to an iron pin in the line of Lot 68; thence with the line of Lot 68, S. 50-42 W. 170 feet to an iron pin on the northeastern side of said Aldridge Drive; thence with the northeastern side of Aldridge Drive, S. 39-18 E. 125 feet to an iron pin; running thence with the curvature of said Aldridge Drive, S. 71-30 E. 52.1 feet to an iron pin and running thence still with Aldridge Drive, N. 70-24 E. 80 feet to the point of beginning.

Being the same conveyed to me by Conyers & Gower, Inc. by deed dated March 16, 1967 and recorded in the R.M.C. Office for Greenville County in Deed Volume 815, at Page \$683.

This is a second mortgage and is junior in lien to that mortgage executed to the First Federal Savings and Loan Association of Greenville, which mortgage is recorded in the R.M.C. Office for Greenville County in Mortgage Book 1059, at Page 289.
