hereinafter called the Mortgagor, in the State aforesaid, Witnesseth:

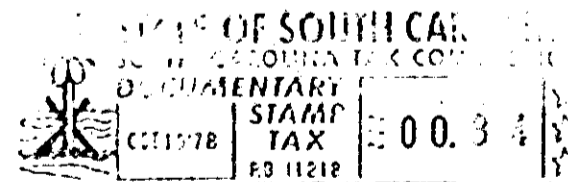

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot No. 3, of Gray Fox Run Subdivision, made by C. O. Riddle, RLX, on November 6, 1975, and recorded in the RMC Office for Greenville County in Plat Book 5-P, at Page 9, and revised March 4, 1976, said revised plat being recorded in the RMC Office for Greenville County, S. C. in Plat Book 5-P, at Page 16, and having, according to said plat, such metes and bounds as shown thereon.
