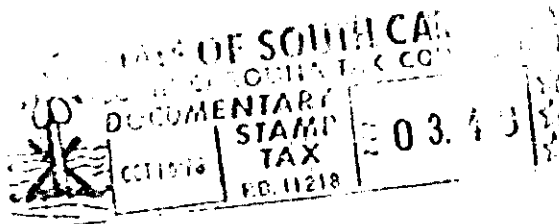

All that piece, parcel or lot of land situate and being in Greenville County, State of South Carolina, being Lot 4 of a Subdivision known as Sunset Heights at Fountain Inn, a plat being recorded in the RMC Office for said County in Plat Book 00, at Page 314; bounded on the Northwest by Lot 5 for 180 feet, on the northeast by undesignated lands for 100 feet, on the southeast by Lot 3 for 187.5 feet, and on the southwest by unnamed street for 100 feet.
