"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying and being on the Southern side of Crescent Court in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 13 on a plat entitled "Estate of T. Q. Donaldson", prepared by C. N. Furman, Jr., dated May, 1930, recorded in the R.M.C. Office for Greenville County, South Carolina, in plat Book I at Page 26 and having, according to said plat, the following metes and bounds:

Beginning at an iron pin on the Southern side of Crescent Court at the joint front corner of Lots Nos 13 and 14 and running thence with the line of Lot No. 14 S. 9-00 W. 145.5 feet to an iron pin in the line of Lot No. 16; thence with the line of Lot No. 16 N. 77-13 W. 52 feet to an iron pin; thence N. 1-45 W. 144.5 feet to an iron pin on the Southern side of Crescent Court; thence with the Southern side of Crescent Court S. 81-00 E. 79.3 feet to the point of beginning.

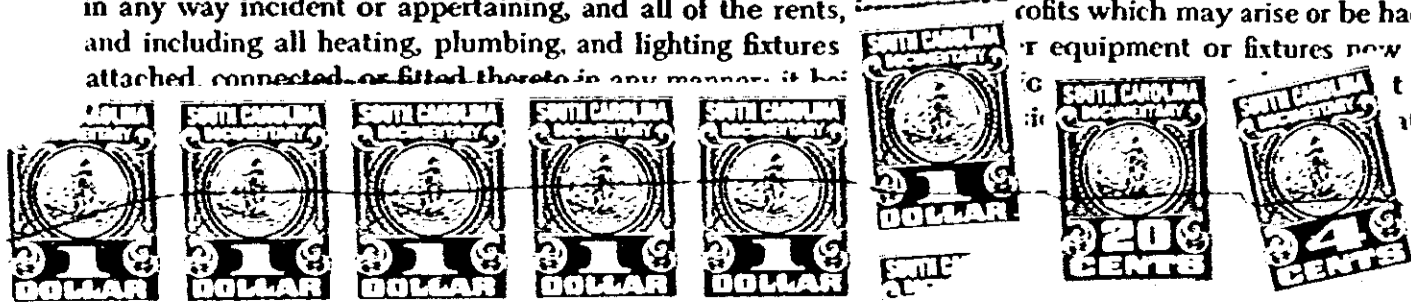
