ALL that piece, parcel or lot of land situate and being in the County of Greenville, State of South Carolina, containing 0.94 acres, more or less, on the southern side of Rosemary Lane described as follows:

BEGINNING at an iron pin at the joint front corner of adjoining property owned by W. Dale Keown and Mickey W. Keown and proceeding thence along the southern side of Rosemary Lane S. 78-18 E. 100 feet to an iron pin; thence leaving Rosemary Lane S. 11-42 W. 49.2 feet to an iron pin; thence S. 11-42 W. 8.9 feet to the center of a branch; thence using the branch as the line, the traverse calls of which are S. 67-54 E. 55.6 feet to an iron pin; thence S. 8-36 E. 78.5 feet to an iron pin; thence S. 56-21 E. 10.6 feet to an iron pin; thence leaving the branch, S. 8-24 W. 21.5 feet to an iron pin; thence S. 8-24 W. 179.2 feet to a stone; thence in a northernly direction along property now or formerly owned by Earl A. McDowell, N. 60-36 W. 176.3 feet to an iron pin in the joint rear corner of adjoining property owned by W. Dale Keown and Mickey W. Keown; thence N. 4-33 E. 286.3 feet O to an iron pin, the point of beginning.
