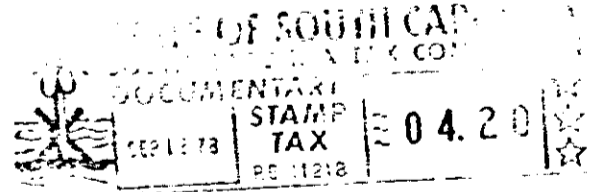

ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina, situate, lying and being on the southern side of Cardwell Street and being known and designated as Lot No. 33 on a plat of Section No. 6, DUNEAN MILL recorded in the RMC Office for Greenville County in Plat Book S at Pages 172 - 177, and being shown on a more recent plat entitled "Property of John A. Cope", prepared by Carolina Surveying Company, dated September 13, 1978, recorded in the RMC Office for Greenville County in Plat Book 62 at Page 43 and having such metes and bounds as shown on the more recent plat, reference to which is hereby made for a more complete description.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:

1. That he will promptly pay the principal of and interest on the indebtedness evidenced by the said note, at the times and in the manner therein provided. Privilege is reserved to pay the debt in whole, or in an amount equal to one or more monthly payments on the principal that are next due on the note, on the first day of any month prior to maturity; provided, however, that written notice of an intention to exercise such privilege is given at least thirty (30) days prior to prepayment.
