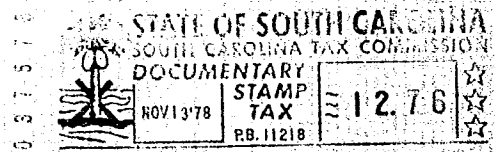
To All Whom These Presents May Concern:
