MORTGAGE OF REAL ESTATE
TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, Curtis V. Chisom and Elouise L. Chisom

(hereinafter referred to as Mortgagor) is well and truly indebted unto Mable C. Reid, 5 Barton Street, Greenville, S. C. 29609

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twelve Thousand and 00/100

Dollars (\$ 12,000.00) due and payable in 120 equal monthly installments consisting of \$152.02 each, the first payment of \$152.02 commencing on the 1st day of December, 1978, and a like payment each month thereafter until paid, except the final installment if not sooner paid consisting of principal & interest due on the November 1, 1988. with interest thereon from date at the rate of nine (9%) per centum per annum, to be paid: annually

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, known and designated as Lot No. 11 of Block F as shown on Plat of Riverside, recorded in Plat Book "A", at page 323, and replatted and recorded in Plat Book "k", at page 281, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin at the southwest corner of the intersection of Highlawn Avenue and Sumter Street, and running thence along the western side of Sumter Street, S 10-15 W 125 feet to an iron pin corner of Lot 22; thence with the line of Lot 22, N 79-45 W 64 feet to an iron pin corner of Lot 10; thence with the line of said lot, N 10-15 E 125 feet to an iron pin on Highlawn Avenue; thence with the southern side of Highlawn Avenue, S 79-45 E 64 feet to the point of Beginning.
