(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Three Thousand Five Hundred Twenty Five and No/100-----

Dollars (\$ 3,525.00 ) due and payable

in accordance with terms of note of even date herewith

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

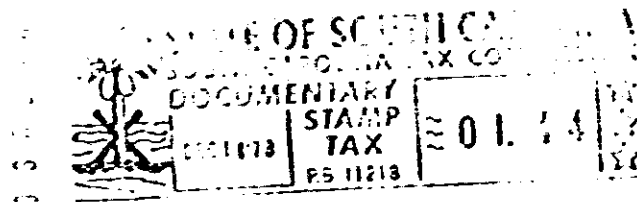
"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, and being shown on a plat of Roy W. and Juanita F. Land prepared by C.O. Riddle, R.S., dated May, 1969, and recorded in the R.M.C. Office for Greenville County on June 20, 1969, in Plat Book 4B, Page 105, said property containing 2.43 acres, designated as Carl W. and Mollie S. Fowler Property located on the south side of State Park Road and having such metes and bounds as shown on said plat.

This property is subject to an easement for ingress and egress from State Park Road, being about twenty (20) feet in width.

This property is also subject to all restrictions, easements, set back lines, road rights of way, including the road right of way for State Park Road, if any, affecting the above-described property.

This is part of the same property conveyed to Mollie S. Fowler by deed of Carl W. Fowler recorded in the R.M.C. Office for Greenville County on August 15, 1969, in Deed Book 874, Page 85.

The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
