ALL that piece, parcel or lot of land, with ball buildings and improvements thereon, situate, lying and being on the western side of Drewry Road, in Greenville County, South Carolina, being shown and designated as Lot No. 14 on a plat of AVONDALE FOREST, SECTION NO. II, made by Piedmont Engineers & Architects, dated August 18, 1964, recorded in the RMC Office for Greenville county, S. C., in Plat Book BBB, page 37, reference to which is hereby craved for the metes and bounds thereof. Said lot being 90 feet by 170 feet deep.

The above property is the same conveyed to the Mortgagor by deed of Betty S. Hunter, recorded December 5, 1978 in Deed Book 1093, page 155.

The within mortgage isjunior in lien to a first mortgage covering the above described property owned by First Federal Savings and Loan Association of Greenville, S. C., in the original sum of \$30,500.00, recorded in the RMC Office for Greenville County, S. C., in Mortgage Book 1343, page 931.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or bereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such firtures and equipment, other than the usual household furniture, be considered a part of the real estate.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
