

MORTGAGE

(Construction-Permanent)

THIS MORTGAGE is made this 10th day of January 1979, between the Mortgagor, Cothran & Darby Builders, Inc.
(herein "Borrower"), and the Mortgagee, South Carolina Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 1500 Hampton Street, Columbia, South Carolina (herein "Lender").
WHEREAS, Borrower is indebted to Lender in the principal sum of Sixty-Five Thousand Two llundre and no/100ths (\$65,200.00).================================

M. C. Office of Greenville, South Carolina in Plat Book 6-H, page 63 and having according to said plat the following metes and bounds, to-wit:
BEGINNING at an iron pin on the Southerly side of Cliffwood Court said pin being the joint front corner of Lot Nos. 362 and 363 and running thence with the common line of said lots S. 25-25 E. 169.65 feet to an iron pin the joint rear corner of Lot Nos. 362 and 363; thence S. 36-05 W. 75.26 feet to an iron pin; thence turning and running N. 59-59 W. 169.41 feet to an iron pin the joint rear corner of Lot Nos. 363 and 364 thence with the common line of said lots N. 23-35 E. 140 feet to an iron pin on the Southerly side of Cliffwood Court; thence with the Southerly side of Cliffwood Court on a curve the chord of which is N. 89-05 E. 62.20 feet to an iron pin the point of beginning.

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant, and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements, or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
