WHEREAS Robert H. Wynne, Jr.

hereinafter referred to as Mortgagor is well and truly indebted to Southern Bank and Trust Company

hereinafter referred to as Mortgagee as evidenced by the Mortgage Agreement dated June 1, 1978, in sum \$13,000.00, principal amount, and interest at the rate of 12% per annum, payable monthly, to be paid to the Mortgagee in the sum of Thirteen Thousand and No/100-----
-----\$13,000.00 due and payable as provided for in Promissory Note executed of even date herewith.

WHEREAS, the Mortgagor may hereafter be liable to the Mortgagee for amounts in excess of the amount of the Mortgage's account for taxes, insurance premiums, public assessments, repair and other expenses;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the above and for value received, does hereby covenant and agree to pay to the Mortgagee the sum of \$13,000.00, principal amount, to the Mortgagee, and also to covenants of the following nature: Duly to pay to the Mortgagee all taxes, interest and other charges and expenses of the property, the payment of which is hereinabove set forth, and to the Mortgagee does grant, bargain, sell and release unto the Mortgagee the following described property:

All that certain piece of land situate and lying in Greenville County, State of South Carolina, bounded to the west by the city of South Carolina, County of Greenville, on the western side of Alice Street, near the City of Greenville, and being shown as Lot No. 10 of Block C on a plat of Woodville Heights recorded in the RMC Office for Greenville County in Plat Book L at Pages 14 and 15 and being described as follows:

BEGINNING at an iron pin on the western side of Alice Street, 120 N. from Oak Street at the corner of Lot 9 and running thence with the western side of said Street, N.02-15 E. 60 feet to an iron pin at the corner of Lot No. 11; thence with the line of said Lot, S.87-45 W. 146.6 feet to an iron pin; thence S.02-15 W. 60 feet to an iron pin at the corner of Lot 9; thence with the line of said Lots, S.87-45 E. 146.6 feet to the beginning corner.

THIS is the same property as that conveyed to the Mortgagor herein by deed from Wade H. Ridgeway recorded in the RMC Office for Greenville County in Deed Book 1088 at Page 690 on September 27, 1978.

TO HAVE AND TO HOLD, all and singular the real property herein described, unto the Mortgagee,

The Mortgagor covenants that it is lawfully owned of the persons by whom it was so held, and that the title to the same is good and valid, free and clear of all liens, encumbrances, claims and other interests and entitles no person except the Mortgagee to whom it is given, and forever after shall belong to the said Mortgagee, free and clear of the Mortgagee and all persons whomsoever had or claiming the same, save as per this instrument.
