Now, Know All Men by These Presents, That the intent of the parties hereto, for better securing the payment of the above Mortgaged indebtedness, on the further sum of One Dollar (\$1.00) to the Mortgagor in hand and delivered to the Mortgagor or his successors in title, in the manner of these presents, the receipt whereof is hereby acknowledged, the grantor does hereby grant, convey, and sell to the Mortgagor, all right, title, and interest, in the following described property:
