TO ALL WHOM THESE PRESENTS MAY CONCERN:

(hereinafter referred to as Mortgagor) SEND (S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Mary Ann Allen (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Three Thousand, Five Hundred Twenty-Five and 00/100----- DOLLARS (\$ 3,525.00) with interest thereon from date at the rate of 8 per centum per annum, said principal and interest to be repaid as follows:

In forty (40) equal quarterly payment of \$128.93, representing principal and interest, commencing on May 1, 1979 and on each August 1, November 1, February 1, and May 1 thereafter until paid in full.
