NOW, KNOW ALL MEN, that the mortgagor(s) in consideration of the said debt, and for the better securing the payment thereof, according to the conditions of the said Note; which with all its provisions is hereby made a part hereof; and also in consideration of Three Dollars to the said mortgager in hand well and truly paid, by the said mortgagee, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said mortgagee, its (his) heirs, successors and assigns forever, the following described real estate: All that piece, parcel or lot of land with all buildings and improvements thereon, situate, lying and being in the County of Greenville, State of South Carolina, being a part of Lots 6, 7, and 8 on plat of property of E. E. Watson, recorded in Plat Book U, at page 181 and having the following metes and bounds, to-wit: BEGINNING at a point on the southern side of Scott Street, which is 112 feet N. 69 37 E. from the Eastern side of Pine Street intersection and running thence along the property now or formerly of Phillips, Watson and Wilson approximately S. 15 E. 155 feet, more or less, to an iron pin on the Northern side of Emory Street; thence with said Street, N. 72 E. 50 feet to a point; thence approximately N. 15 W. 155 feet, more or less, to an iron pin on Scott Street, thence with Scott Street S. 69-37 W. 50 feet to the point of beginning. Being the same property conveyed to Rush H. Trammel and L. C. Black by deed of E. Inman, Master, dated May 27, 1963 and recorded in the RMC Office for Greenvlle County in Deed Book 723 at page 516. ALSO being the same property conveyed to the grantor herein by deed of Rush H. Trammel and L. C. Black dated May 1, 1964, and recorded in the RMC Office for Greenville County in Deed Book 749 at page 270. This property is subject to a mortgage given to Rush H. Trammel, et al by Mildred McKinney as noted in Mortgage Book 959, page 268, in the Office of the RMC for Greenville County with a balance of TWO THOUSAND ONE HUNDRED DOLLARS (\$2,100.00). This is the identical property conveyed to Bert O'Dell Rogers by deed of Mildred McKinney on 10/15/66 and recorded 7/29/68 in the office of the RMC for Greenville County, S. C. in Deed Book 849, page 297. IT IS HEREBY UNDERSTOOD THAT THIS MORTGAGE CONSTITUTES A VALID FIRST LIEN ON THE ABOVE TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise DESCRIBED PROPERTY. TO HAVE AND TO HOLD, all and singular the said Premises unto the said mortgagee, its (his) successors, heirs and assigns forever. AND I (we) do hereby bind my (our) self and my (our) heirs, executors and administrators, to procure or execute any further necessary assurances of title to the said premises, the title to which is unencumbered, and also to warrant and forever defend all and singular the said Premises unto the said mortgagee its (his) heirs, successors and assigns, from and against all persons lawfully claiming, or to claim the

same or any part thereof. AND IT IS AGREED, by and between the parties hereto, that the said mortgagor(s) his (their) heirs, executors, or administrators, shall keep the buildings on said premises, insured against loss or damage by fire, for the benefit of the said mortgagee, for an amount not less than the unpaid balance on the said Note in such company as shall be approved by the said mortgagee, and in default thereof, the said mortgagee, its (his) heirs, successors or assigns, may effect such insurance and reimburse themselves under this mortgage for the expense thereof, with interest thereon, from the date of its payment. And it is further agreed that the said mortgages its (his) heirs, successors or assigns shall be

entitled to receive from the insurance moneys to be patd, a sum equal to the amount of the debt secured by this mortgage.

AND IT IS AGREED, by and between the said parties, that if the said mortgagor(s), his (their) heirs, executors, administrators or assigns, shall fall to pay all taxes and assessments upon the said premises when the same shall first become payable, then the said mortgagee, its (his) heirs, successors or assigns, may cause the same to be paid, together with all penalties and costs incurred thereon, and reimburse themselves under this mortgage for the sums so paid, with interest thereon, from the dates of such payments.

AND IT IS AGREED, by and between the said parties, that upon any default being made in the payment of the said Note, when the same shall become payable, or in any other of the provisions of this mortgage, that then the entire amount of the debt secured, or intended to be secured hereby, shall forthick become due, at the option of the said mortgages, its (his) heirs, successors or assigns, although the period for the payment of the sold debt may not then have expired.

AND IT IS FURTHER AGREED, by and between the said parties, that should legal proceedings be instituted for the foreclosure of this mortgage, or for any purpose involving this mortgage, or should the debt hereby secured be placed in the hands of an attorney at law for collection, by suit or otherwise, that all costs and expenses incurred by the mortgagee, its (his) heirs, successors or assigns, including a reasonable counsel fee (of not less than ten per cent of the amount involved) shall thereupon become due and payable as a part of the debt secured hereby, and may be recovered and collected hereunder.

PROVIDED, ALWAYS, and it is the true intent and meaning of the parties to these Presents, that when the said mortgagor, his (their) heirs, administrators shall pay, or cause to be paid unto the sald mortgagee, its (his) heirs, successors or assigns, the said debt, with the interest thereon, if any shall be due, and also all sums of money paid by the said mortgages, his (their) heirs, successors, or assigns, according to the conditions and agreements of the said note, and of this mortgage and shall perform all the obligations according to the true intent and meaning of the said note and mortgage, then this Deed of Bargain and Sale shall cease, determine and be void, otherwise it shall
