MORTGAGE OF REAL ESTATE
TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, Joseph D. Beck and Robin T. Beck

(hereinafter referred to as Mortgagor) is well and truly indebted unto M. L. Frabie and Anna A. Frabie

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twenty-seven Thousand Four Hundred and no/100-----

Dollars (\$ 27,400.00) due and payable

in two hundred forty (240) monthly installments of Two Hundred Twenty-nine and 19/100 (\$229.19) Dollars each, commencing April 1, 1979, and due on or before the first day of each and every month thereafter until paid in full

with interest thereon from this date at the rate of eight per centum per annum, to be paid: to mortgagees through a special payment account set up with South Carolina Federal Savings and Loan, P. O. Box 937, Greenville, S.C., 29602.

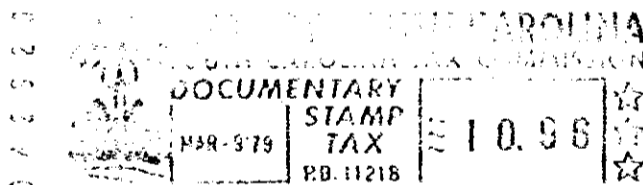
WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing 3.37 acres, more or less, and being known and designated as Lot 3 (containing 1.19 acres) and part of Lot 5 (containing 2.08 acres) according to a plat prepared by C. O. Riddle, RLS, dated June 12, 1969, and having such metes and bounds as are more fully shown thereon.

This being the same property conveyed to mortgagors herein by deed of M. L. Frabie and Anna A. Frabie dated March 8, 1979, recorded in Book 1098 at Page 60 on March 9, 1979.

Mortgagors have option of prepayment without penalty.



Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
