

ALL that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville being shown and designated as Lot No. 10 on a plat of Sherman Park, Section I, recorded in the RMC Office for Greenville County in Plat Book 4-F at Page 5 and also shown on a plat of Property of Marshall L. Sherman and Cathrine L. Sherman dated March 20, 1979, prepared by Century Land Surveying Company and having, according to said plats the following metes and bounds, to-wit:

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:
