WITNESSETH, that for the consideration hereinaster stated, receipt of which is hereby acknowledged, the mortgager does hereby mortgage, sell, grant, assign, and convey unto the mortgagee, his successors and assigns, all of the following described property situated and being in the County of Greenville

State of South Carolina,


All those certain pieces, parcels or lots of land situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as Lot Nos. 16 and 17 on a plat entitled "Subdivision for Columbia Investment Co." made by Piedmont Engineers & Architects dated July 9, 1965, and recorded in the R. M. C. Office for Greenville County in Plat Book KKK at Page 73 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corner of Lots 16 and 18 running thence along the line of Lot No. 18 and unnamed property N. 36-52 W. 200 feet to an iron pin; thence N. 59-09 E. 150 feet to an iron pin on the southwestern side of St. Marks Road; thence with the southwestern side of St. Marks Road S. 36-52 E. 200 feet to an iron pin at the northwest intersection of Jonquil Lane and St. Marks Road; thence along Jonquil Lane S. 59-09 W. 150 feet to the point of beginning.

Lot No. 16 was conveyed to the grantor herein by deed of W. N. Leslie, Inc. dated June 3, 1968, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Deed Book 845 at Page 432.

Lot No. 17 was conveyed to the grantor herein by deed of W. N. Leslie, Inc. dated June 10, 1970, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Deed Book 891 at Page 631.

The above description is taken verbatim from deed to George V. and Mary E. Mappin. The above-described property was conveyed to mortgagors by deed of Harry O. Yearick recorded August 21, 1972, in Greenville County R.M.C. Office in Deed Book 952, Page 432.

To have and to hold the same unto the mortgagee and the successors in interest of the mortgagee forever o in fee simple or such other estate, if any, as is stated herein.

The mortgagor covenants that he is lawfully seized and possessed of and has the right to sell and convey said property; that the same is free from all encumbrances except as hereinabove recited; and that he hereby binds himself and his successors in interest to warrant and defend the title aforesaid thereto and every part thereof against the claims of all persons whomsoever.
