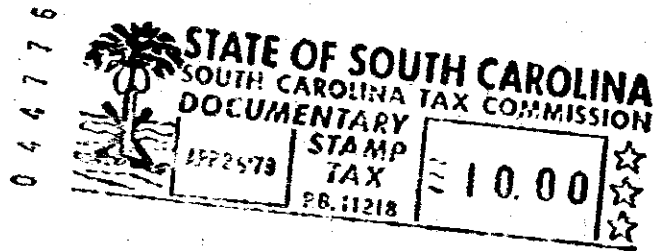
with interest thereon from date hereof at the rate of 10.8 per centum per annum, to be paid: Monthly

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and shown on plat prepared by Carolina Engineering & Surveying Co., December 1964, entitled "Final Plat Farmette Heights near Travelers Rest, S. C.", and containing 20.1 acres, more or less, and being all of the tract of land on the northeasterly side of White Horse Road which is shown as containing 24.1 acres, more or less, less, however, the four acres, more or less of said tract which was conveyed to Larkins Bridges and Mary Jane Bridges, on November 4, 1967, deed recorded in Deed Book 832, Page 278.
