WHEREAS, the Mortgagor is well and truly indebted unto John G. Cheros

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Six Thousand Three Hundred Seventy eight and 66/100-----
DOLLARS (\$ 6,378.66--).

with interest thereon from date at the rate of eight per centum per annum, said principal and interest to be repaid:

Due and payable three years from date. Interest to be computed and paid with each release and in the event no release payments are made during any calendar year, payable annually beginning one year from date. Mortgagee agrees to release individual lots not exceeding 15,000 square feet from the lien of this mortgage upon the payment of all accrued interest plus \$300.00 paid toward principal for each release.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

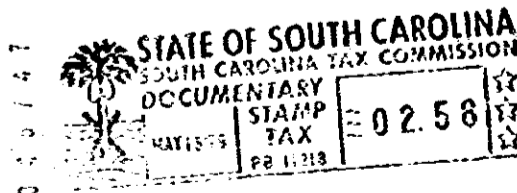
