BEGINNING at an iron pin at the joint front corner of Lots 9 and 10, and running thence along Oak Forest Drive S. 77-50 W. 100.0 feet to an iron pin to the joint front corner of Lots 10 and 11, and running thence N. 12-10 W. 180.3 feet to an iron pin; thence N. 82-32 E. 100.3 feet to an iron pin; thence S. 12-10 E. 172.0 feet to the point of beginning.
