"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as the Western One-half of Lot No. 72 and the western 60 feet of Lot No. 73, Thornwood Acres, Sec. 2, as shown on plat recorded in the RMC Office for Greenville County in Plat Book MM at Page 105, and also shown on plat entitled "Property of John P. Scott and Vickie E. Scott," as recorded in the RMC Office for Greenville County in Plat Book ZZZ at Page 171-A, and having such metes and bounds as are more fully shown thereon.
