THIS MORTGAGE, made this 5th day of June, 19 79, by Gene Ragsdale and Sandra T. Ragsdale hereinafter called the Mortgagor, in the State aforesaid, Witnesseth:

ALL that lot of land in the County of Greenville, State of South Carolina, being known and designated as Lot No. 46 on plat of Cochran Heights Addition, property of Mrs. N. C. Cochran Estate recorded in Plat Book WWW, Page 21, said lot having a frontage of 100 feet on the south side of Maxcy Avenue, a depth of 186.7 feet on the east side, a depth of 193.7 feet on the west side, and a rear width of 100.3 feet.
