evidence of such insurance shall be kept by the Issuer and made available to any bond holder for inspection during reasonable hours. A Mortgage Clause shall be attached to the policy naming the Trustee in the First Mortgage of Real Estate and said Trustee shall be empowered to act as set forth in the First Mortgage of Real Estate. In the event of damage or destruction of such property and recovery therefor under such insurance, the Issuer will, as soon as possible, replace or repair such property or use the money received under the insurance policy to retire the bonds issued hereunder.

(2) The Issuer will, unless hereinafter provided to the contract, use and expend the proceeds derived from the sale of the bonds issued hereunder only for the purpose of construction of a new educational and office building, debt retirement, furnishings for new building, architect's fees, attorney's fees, appraisal fees, financing service costs, landscaping and other relevant expenses upon the following described property, which said property is subject to a First Mortgage of Real Estate and which is described as follows:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, about one-half mile West of the City of Greer, lying South from Old U.S. Highway No. 29 (now St. Highway No. 290), having the following courses and distances, to-wit:
