

ALSO:

ALL that certain piece, parcel or lot of land with buildings and improvements thereon situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, near the Corporate Limits of the City of Greenville in Tax District 235, and being known and designated as Lot No. 181 of a Subdivision of the Village of Mills Mill as shown on a plat thereof made by Piedmont Engineering Service of Greenville, S.C. in June, 1954 and recorded in the RMC Office for Greenville County in Plat Book "GG", at Pages 60-61, and having such metes and bounds, courses and distances as shown thereon. This property being known as house No. 144-145 Ridge Street.

ALL that certain piece, parcel or lot of land with buildings and improvements thereon situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 43, Section 1 of the Judson Mill Village as shown on plat thereof prepared by Dalton & Neves, August 1939 and recorded in the RMC Office for Greenville County in Plat Book "K" at Pages 11 and 12.

BEGINNING at an iron pin on the East side of Fifth Avenue, 215 feet South of the Southeastern corner of the intersection of Heatherly Drive and Fifth Avenue; running thence with Fifth Avenue, South 4-30 West 70 feet to an iron pipe, joint front corner of Lots 42 and 43; thence with line of Lot No. 42, South 85-30 East 89.5 feet to an iron pin, joint rear corner of Lots 35 and 36; thence with line of Lot 35, North 4-30 East 70 feet to an iron pin, joint corner of Lots 34 and 35 and Lots 43 and 44; thence with the line of Lot 44, North 85-30 West 89.5 feet to an iron pin, the beginning corner.

ALL that piece, parcel or lot of land with buildings and improvements thereon situate, lying and being in the County of Greenville, State of South Carolina on the South side of Eleventh Street of Section 5, Judson Mill Village and being known and designated as Lot 88 as shown on plat of Section 5 of Judson Mills Village made by Dalton & Neves, Engrs. February 1940; which plat is recorded in Plat Book K, at pages 33 and 34, RMC Office for Greenville County.

BEGINNING at an iron pin on the South side of Eleventh Street, joint corner of Lots 88 and 89, said pin being 162.6 feet West from the Southwest corner of the intersection of Eleventh Street and Honour Street; running thence along line of Lot 89, South 1-55 East 160 feet to an iron pin; thence South 88-05 West 70 feet to an iron pin; thence with line of Lot 87, North 1-55 West 160 feet to an iron pin on the South side of Eleventh Street; thence with said South side of Eleventh Street, North 88-05 East 70 feet to the beginning corner.
