(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twenty Thousand and No/100-----  
-----Dollars (\$20,000.00) due and payable

\$248.35 on July 15, 1979 and a like amount on the 15th of each month thereafter until paid in full with interest first deducted and balance to principal for a total of 144 payments with right of anticipation,

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Austin Township, containing 13.25 acres in accordance with plat made for Alvin H. Thackston, et al by Carolina Surveying Company, R.L.S., 112 Manley Street, Greenville, South Carolina, May 18, 1979, and being more fully described in accordance with said plat, to-wit:

BEGINNING at an iron pin on the western side of Adams Mill Road, said point being 1548.96 feet from the intersection of Adams Mill Road and Scuffletown Road, and running thence along said Adams Mill Road, S. 7-55 W. 295.9 feet to an iron pin; thence S. 74-40 W. 765.5 feet to a stone; thence S. 45-32 W. 613.5 feet to an iron pin; thence N. 20-11 E. 1291.2 feet to an iron pin; thence S. 69-30 E. 823.2 feet to an iron pin, being the point of beginning.
