To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding of any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of **Greenville**

All that lot of land in the County of Greenville, State of South Carolina, near Greenville, S.C., known as a portion of Lot No. 24 and Lot No. 25, Block E, according to plat of Washington Heights made by N. C. McDowell, Jr. and Julian P. Moore, dated December, 1944 and recorded in the R.M.C. Office for Greenville County in Plat Book "M" at page 107, reference to which plat is craved for a fuller description.

This being the same property conveyed to me by J. H. Mauldin by deed recorded in the R.M.C. Office for Greenville County at Deed Book 532, page 412.

Derivation is as follows: Deed Book 845, Page 17, From Herbert Roberts, dated May 28, 1968.

If I pay the note secured by this mortgage according to its terms this mortgage will become null and void.

I will pay all taxes, liens, assessments, obligations, encumbrances and any other charges against the real estate and maintain insurance on the real estate in your favor in a form and amount satisfactory to you. If I am in default for failure to make a required payment for 10 days or more, you may send me a notice giving me 20 days to eliminate the default. If I do not eliminate the default in the manner stated in the notice, or if I eliminate the default after you send the notice but default on a future payment by failing to pay on schedule, or if my ability to repay my loan or the condition, value or protection of your rights in the collateral securing my loan is significantly impaired, then the full amount I owe, less any charges which you have not yet earned, will become due, if you desire, without your advising me.

I will pay all expenses you incur in enforcing any security interest, including reasonable attorney's fees as permitted by law.

Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.

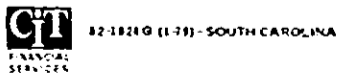
Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.
