To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding of any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville

All that piece, parcel or lot of land in Greenville Township, Greenville County State of South Carolina, on the west side of 8th Avenue in Judson Mill Village No.2 and being known and designated as Lot No. 12 in Block F, as shown on plat made in March 1939, recorded in Plat Book "K" at page 1 and 2, said lot fronting 50 feet on the west side of 8th Avenue. This being the same property conveyed to Raymond M. Boroughs by Wade H. Ridgeway deed dated 6th February 1945 and recorded in the R.M.C. Office of Greenville County recorded on 7th day September 1945 in deed Book 280 at page 54.

I will pay all expenses you incur in enforcing any security interest, including reasonable attorney's fees as permitted by law.

Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.

Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.

This mortgage will extend, consolidate and renew any existing mortgage you hold against me on the real estate described above.
