Lender's written agreement or applicable law. Borrower shall pay the amount of all mortgage involvance premiums in the

Lendor's Artien agreement or applicable law. Borrower shall pay the amount of all mortgage insurance premiums in the manner provided under paragraph 2 hereof.

8. Inspection.
