

BEING in all respects the same lot of land conveyed to the North Carolina Telephone Company by deed dated September 20, 1955 from Robert J. Keelyn and wife, Myrtle B. Keelyn, which is recorded in the Anson County Public Registry in Deed Book 125 at page 353.

PARCEL II: BEGINNING at a point in the center of Secondary Road #1418, a corner of the O. E. Ross heirs, and runs thence with the center of the aforesaid road, S. 66-13 W. 246.4 feet to a point in the center of said road, the southeastern corner of Lot #2; thence with the dividing line between Lots #2 and #3, N. 43-50 W. 239 feet to a stake, the northernmost corner of Lot #2; thence N. 38-19 E. 43 feet to a stake; thence N. 69-49 E. 220.8 feet to a stake, the northernmost corner of Lot #3; thence S. 26-17 E. 180 feet, thence S. 52-24 E. 141 feet to the point of beginning, the same being a lot carved from that tract of land conveyed to North Carolina Telephone Company by Robert J. Telephone Company", made by F. S. Clarke, R.L.S., dated March 30, 1970 which said plat is recorded in the office of the Register of Deeds for Anson County, N. C., in Plat Book 6, Page 86, reference to which is hereby made.

BEING the same parcel of land as conveyed to Ann Sullivan and Emma Wheless by North Carolina Telephone Company by deed dated April 14, 1970 and recorded in Book 167, Page 609, Anson County Registry.

Parcel 45 ANSON COUNTY

LYING in Lilesville Township, Anson County, and more particularly described as follows:

Being Lots Nos. 9 and 10 according to that plat, plan and survey entitled "Property of Cape Fear Wood Corporation", made by P. M. Carter, L.S., dated October 18, 1949, recorded in Plat Book No. 4 at Page No. 94, Registry of Anson County, and reference is hereby made to the aforesaid plat for a more particular description of said lots or parcels of land and the description by metes, bounds, courses and distances as thereon contained are by reference hereby expressly made a part of this indenture.

Parcel 46 ANSON COUNTY

LYING and being on the West side of Morven Road in the Town of Wadesboro, Anson County, North Carolina and more particularly described as follows:

BEING Lot 1, Block 1 and BEGINNING at a stake on the southeast corner of Lot #1 where Morven Road and Covington Streets intersect, and runs N. 4-20 E. 70 feet to the east corner of Lots 1 and 2, thence N. 85-40 W. 140 feet to the east line of Lot #20, thence S. 4-20 W. 70 feet to Covington Street; thence with Covington Street S. 85-40 E. 150 feet to the point of beginning.
